The President called the meeting to order at 10:03am and the Secretary read Article 10.02 of the By-Laws. Laura noted that digital versions of the RNBRA policies are available on the RNBRA website in English and French. She also noted that the meeting was being recorded, but only for reference when preparing the minutes. It will be deleted upon approval of the formal minutes.

1. Moment of Silence: The President noted we lost several members this year, including Paul Bastarache and Jim McGee. A moment of silence was observed to honour our deceased comrades of the shooting fraternity.
2. Opening Remarks: The President welcomed those in attendance.
3. Agenda Approval: The President asked the floor for any amendments to the agenda. Conrad requested to add Item 6.8 – Poor Boy Hunter Activity Report. Steven motioned to approve the agenda as amended. The motion was seconded and PASSED.
4. Minutes of 2021 AGM: The Secretary circulated the minutes of the 2021 AGM prior to the meeting. No errors or omissions were noted. Steven motioned to accept the minutes as distributed. The motion was seconded and PASSED.

6.4. Pistol Section Report: Steven presented his report. The 2022 pistol shooting season went well. The following RNBRA Championships were hosted:

- Practical Pistol
- 2021 George MacGillivray 3-Gun (held over)
- 2022
- Single Stack
- Revolver

The pistol championships were well received and the clubs are looking forward to hosting in 2023. The Pistol Service Condition Championship was not held, as no clubs were able to host. Match reports and photos have been filed with the Secretary.

6.5. Fullbore Section Report: Adam MacDonald read his submitted report. See attached.

6.6. Shotgun & Smallbore Report: Steven presented their report. The Shotgun Championship was hosted by Fredericton Trap & Skeet Club. Attendance was down in 2022. Results and photos have been sent to the Secretary. FTSC is looking forward to hosting again in 2023. Conrad noted he attended this event and everyone there had a good time.

No clubs expressed interest in hosting the Smallbore Championship, so it was not held in 2022. Most clubs are shooting .22 rifle at 25-100m steel events held around the province and across the country. A discussion was held regarding clubs that may be able to host in 2023.

6.7. Benchrest Report: Conrad read his submitted report. See attached.

6.8. Poor Boy Hunter Report: Conrad read his submitted report. See attached.

6.9. Steven motioned to accept all Activity Reports. The motion was seconded PASSED.

7. Committee Reports

7.1. Audit Committee Report: The Chair of the Audit Committee, Ken Kyle, presented their report. Ken and Steven Stewart met with Gord and reviewed and audited the current financial records. Everything appeared to be in good order.

7.2. Trophy Trustee: Mark presented his Trophy Trustee report. See attached.

7.3. Club Outreach: Steven presented his Club Outreach report. He visited and made general introductions to several clubs in 2022. An Intro Rifle Shoot was held at Club de Tir Chaleur Shooting Club in Bathurst that was well received. Steven completed two range pre-inspections and both ranges passed their final inspections. Steven held one CRO course that was attended by 8 students. The paper target program is still active; Steven provides paper targets to affiliated clubs. The supply is ok for 2023. Steven visited a club in Cape Pele for their cowboy shoot and they expressed interest joining the RNBRA and running a championship.

7.4. Awards Committee: No submissions were made, so no awards were presented. Gord noted that the RNBRA was contacted by Andy Gunter's granddaughter who sent us some historical information that she found when cleaning up her attic, including old RNBRA programs and photos.

7.5. DCRA Representative Update: Gord represents the RNBRA on the DCRA Advisory Committee as a non-voting member. Daniel is an elected member representing New Brunswick on the DCRA Council.

The first issue discussed was access to military ranges (in particular Base Gagetown in NB). The agreement that allowed PRAs use of military ranges free of charge is no longer in place. The DCRA has been negotiating a new service agreement where PRAs provide marksmanship competition and training opportunities for those in the Armed Forces in exchange for use of the ranges. PRAs will have to sign off on this agreement and commit to offering those services.

The TR Nationals were held at Connaught Range, but the F-Class template was not approved so the F-Class Nationals could not be held. Daniel said the DCRA is committed to running the F-Class Nationals in 2023, but it may be at a different range (e.g. in Toronto or Quebec).

Chair of DCRA Council, Scott Bissett, resigned this year from all positions with the DCRA. He has been replaced by Scott McInnis and they are optimistic Scott will perform well in this role.

7.6. Website Update: Laura read their submitted report. See attached.

7.7. Nominations Committee: Committee Chair, Mark, read his submitted report. See attached.

7.8. Conrad motioned to approve all reports. The motion was seconded PASSED.

8. Election of Officers:

8.1. Laura presented her report. On October 25, letters and ballots were mailed to all members and club representatives. As of Friday, November 4, 18 ballots were returned. Votes were unanimously for all candidates. Congratulations to all.


The 2022 shooting season was filled with many enjoyable provincial level matches in all the shooting sports. In addition, NB athletes attended, and were successful, in national and international level competitions. It was a welcome return to normalcy following two years of pandemic conditions with limited access to shooting facilities and competitive matches.

During the past year the RNBRA has continued to support the development of civilian marksmanship by partially funding shooting programs for youth, and other under-represented groups, firearms safety training, range inspection support, and provincial championships in several disciplines. Most of these events were hosted by our 15 affiliated gun clubs in the province which include 3400 members.

The past year has also brought changes to the Firearms Act which threaten the shooting sports with prohibitions on rifles and handguns. These restrictions eliminate service rifle competition as we know it, extended long range shooting, and prevents the growth of the pistol shooting sports such as IPSC. It must be remembered that the Firearms Act is a political document and therefore is shaped by public opinion. If we are to continue to enjoy the shooting sports, and share that enjoyment with future generations, we must earn the public trust and support politicians that support responsible gun ownership and the interests of the shooting community.

I have enjoyed serving as President of the RNBRA and working with the volunteers on the RNBRA Board this past year. I look forward to another enjoyable shooting season in 2023.

Membership Report

In 2022, the RNBRA had 65 individual memberships. This is down a little from the previous year, but membership has not changed significantly since 2020. 8% of members identify as female. There were no members under the age of 19. As of this report, there are five honorary members.

In 2022, a total of 15 shooting clubs affiliated with the RNBRA, which comprised of 3404 members. Of the data provided, 7% of the clubs' membership identified as female and 2.5% were under 19.

The RNBRA had two programs for 2022 related to club membership. The first year's membership was waived for any club that hadn't affiliated in the past five years. This program was to encourage new clubs to join the RNBRA. We had one new club affiliate (Madawaska – 400 members). Also, affiliation fees were capped at \$200; i.e. any club that had more than 180 members did not have to pay more than \$200 affiliation fee. Eight clubs in 2022 had over 180 members.

2022 Annual Report of the RNBRA Fullbore Section

to the Annual General Meetings of the Royal New Brunswick Rifle Association and Fullbore Section

2022 was a successful year for fullbore shooting in New Brunswick.

Our annual prize meet was held at Batouche on June 25 and 26. There were 23 competitors including 5 from Quebec. TR class was won by Paul Tremblay from Quebec, FTR 1st place was Gord Holloway, and F-Open 1st place was Andrew Justason. We had 11 different winners across the matches throughout the weekend and it was very well organized by Mark McMullin and Laura Kaderly.

This year four New Brunswick FTR shooters travelled to Bisley in July to form the Canadian team which included Adam MacDonald, Gord Holloway, Ken Kyle, Tony Pham, and Evangeline Colman-Sadd. However, we arrived to find the range had caught on fire, and the F-Class Imperial match was cancelled.

Adam and Gord travelled back to Bisley in September for the European F-Class championship. In the individual competitions Adam finished 6th and Gord 21st. We also joined two British TR shooters who had never shot F-Class before, and after an afternoon of practice, we won the team match. It was a very successful event.

Unfortunately we lost our friend Paul Bastarache this year. He was a very accomplished benchrest and F-Class shooter, and was very supportive and helpful to new shooters learning F-Class. He helped to build the Saint Gabriel range which hosted many of our fullbore matches over the years. We will miss him.

On May 21, Laura Kaderly organized our first annual RNBRA open team match. The Quebec team won in TR class on both days. In F-Class, the Saturday event was won by Ken Kyle, Gord Holloway, Dick Platt, and Nicole Langer who was shooting for the first time. Sunday was won by the Bisley FTR team consisting of Adam MacDonald, Gord Holloway, Harrison Brown, and Ken Kyle. The match was very successful and we hope to continue this event next year.

Gord Holloway hosted a special 155 match, intended to encourage F-Class shooters to use a lighter bullet for a greater wind reading challenge. However, there happened to be a hurricane that weekend, and only Gord and myself were there. We shot in the heavy winds and experienced wild swings from 3 to 9 minutes. It was quite the day.

We also hosted the Atlantic Championships on September 3 and 4 with 20 competitors. First place in TR went to Braden Colman-Sadd and Gord Holloway finished 1st in FTR.

Mark McMullin ran into range approval problems with Gagetown this year and was unable to run any precision rifle matches. We hope to resolve those issues over the winter so the program can continue next year.

The Canadian F-Class nationals were cancelled again this year, however the TR nationals took place during the week of August 15 to 21. Daniel Chisholm was the only competitor from New Brunswick and finished 38th.

The traditional Mini Palma team match took place this September in Keene, New Hampshire and six New Brunswick shooters attended: Adam MacDonald, Tom Murphy, Benoit Vautour, Daniel Chisholm, Colin Hitchcock, and Bob Kierstead. This year the Maritimes team took the prize. We look forward to hosting the Americans in Nova Scotia next year.

Thank you to Ken Kyle and Ron Surette, and the St Antoine Gun Club for hosting 5 matches this year. Thanks also to our Fullbore section executive, which consists of myself (chairman), Mark McMullin (vice chairman), Ken Kyle (treasurer), and Kim Justason (secretary). Thank you also to Gord Holloway and Laura Kaderly for organizing and helping to run many great events this year.

The Centerfire event had 10 competitors entering into one or both of the following classes:

CF Sporter Class: Winner was Guy Huestis. 2nd place was Wayne Kennedy.

October 2, 2022

The Rimfire event had 24 persons entering into one or both of the following classes:

RF Open Class: 18 competitors. Winner was Dale Hawkins. 2nd place was Matt McAllister.

RF Sporter Class: 11 competitors. Winner was Guy Huestis. 2nd Place was John Moore.

The Club provided free lunch at each event. All functions necessary to run the event (Range Officers, Relay arranging, Scorers, Target preparation, Target changers, Lunch, Match Direction) were handled willingly and capably by club members.

RNBRA presented first and second place medals (8 in total) and will have the RNBRA Plaque engraved with the winners' names in each class.

These events were held concurrent with regularly scheduled club matches. Club President David Chevarie was Match director. Matters related to RNBRA were handled by myself.

Entry fee for each Class was \$5 additional to the \$10 usual fee charged for the concurrent club event. Entry was open to any provincial resident.

Both days went very well. There was a minor procedural issue which delayed formal announcement of the event dates. Pre-registration was not affected. The matter was resolved by formal vote approving the dates at the club's preceding quarterly meeting. All clubs with active benchrest shooters were notified in sufficient time. No complaints, no problems.

My guess is that Minto is very likely to express willingness to host the events again in 2023. Several other locations could be suitable but Minto is able and willing to conduct the event sanctioned by RNBRA. Some other locations would require RNBRA itself to conduct the matches. This would be onerous.

REPORT TO 2022 RNBRA AGM

NEW RIMFIRE COMPETITION “BASIC HUNTER RIMFIRE CLASS” (“PoorBoy”)*

Several of us (Steven Stewart, John Moore and Gerry Johnson) have been involved with initial development work and trial matches in 2022. This Class is an attempt to create a match which is fun, simple and within the financial reach of persons who are unable or unwilling to invest large sums in shooting equipment. It can be shot on most ranges at 25, 50 and maybe 100 yards.

The other feature is that there are no classes. Considerable leeway in equipment is allowed within restrictions confining it to affordable equipment. Differences in equipment that affect scores are compensated for through “bonuses” allotted to lesser equipment. That way the shooter with the Cooney open sights shoots against the Savage with scope, for example. Attached are the draft rules, which should make it clearer.

It is still subject to being fine-tuned but it is very promising. We have had 5 informal trial matches at Lake George Gun Club to see what bugs needed working out. We have settled on targets which are suitable for all sights at 25 and 50 yards/meters. Shooter response is hard to predict but all who have tried it enjoyed it! We are very optimistic. One thing is certain: This will not be allowed to become an equipment race.

At the Lake George Gun Club AGM we were directed to discuss it up with their Competition Committee with a view to consider having one formal match added to their shoot schedule. Although it has not yet been discussed, perhaps this may lead to sounding out other clubs for possible interest and demonstrations. Ultimately, a formal championship may be sought if it proves popular enough.

So far, a dozen of us have shot in one or more of the trial matches. Everyone has enjoyed it and asked for more. We almost all own and compete with better equipment than is allowed in this class but it still has a strong appeal. Simple, inexpensive, fun, non-intimidating to beginners or those who are on a budget.

I would like to present the IPSC NB report for the 2022 season. During this reporting period we as a section have had a very successfully year within our sport. Our leadership, Instructors, Range Officers, Chief Range Officers, and members organized, and enjoyed a full outdoor season.

The province/clubs hosted approximately x25 Lev 1&2 matches, and x2 Lev 3 matches.
